
### SEPTEMBER MEMBERSHIP HISTORY






### REVENUE LIMIT HISTORY




### **EQUALIZED VALUATION HISTORY**



### GENERAL STATE AID HISTORY




### PER PUPIL AID HISTORY




### 2022-23 EXPENSE BUDGET BY OBJECT - GENERAL (10) AND SPEC. ED (27) FUNDS

#### DEBT SERVICE SCHEDULE - FUND 39


The district's Fund 39 debt service will be paid off on March 1, 2023. Total principal outstanding as of July 1, 2022 is \$1,415,000.


